## **Research Proposal**

## Introduction:

More golf courses are investing in the use of zoysiagrass for use on fairways and putting greens. Extensive testing must be performed prior to release and commercialization of new cultivars of zoysiagrass intended for use in the golf course industry. Desired characteristics for the golf course industry include disease resistance, primarily Rhizoctonia, shade tolerance and little thatch accumulation. Additionally, one of the most important factors considered by the golf course industry when selecting a new grass is playability, or ball roll speed.

The University of Florida's zoysiagrass breeding program under the direction of Dr. Kevin Kenworthy is seeking a sponsor for the evaluation of advanced and less-advanced zoy-siagrass lines for potential release and use on golf course fairways and putting greens.

## **Objectives:**

The primary objective of this project will be to evaluate the adaptation of advanced zoysiagrass lines (Table 1), both within Florida and outside of Florida. The sponsor will provide financial support for trials at three locations within Florida. It is desired that the sponsor assist the University of Florida zoysiagrass breeding program in additional evaluation of the advanced lines at sites or other university research locations outside of Florida. The sponsor will be responsible for site identification and financial support for trials outside of Florida. Adaptive evaluations may include fairway and putting green maintenance, disease resistance, shade tolerance and ball roll speed. Material transfer agreements between the University of Florida and locations within and outside of Florida will provide for transfer of advanced lines from the breeding program.

## **Objectives (con't):**

Another objective of this project will be to support the evaluation of less advanced lines (Table 1) at a single location. Additional funding will be required for future evaluation of these lines prior to consideration for release.

## Site Layout, Installation and Management of Trials with Advanced Lines:

- 1. Plots will be planted with sprigs.
- 2. Sprigs will be produced and provided by Kevin Kenworthy.
- 3. Treatments: (5 putting green types + Diamond Zoysia; and 8 fairway types).
- 4. Plot size: 5 x 15 ft. for putting green types; 10 x 10 ft for fairway types.
- 5. Replications: 3.
- 6. Distance between plots: no borders between plots.
- 7. Total minimal test area: 1,350 sq. ft. for putting green types; 2,400 sq ft. for fairway types.
- 8. Locations: WFREC (Jay, FL), PSREU (Citra, FL), FLREC (Ft. Lauderdale, FL).
- 9. The soil at the site must be weed free, uniform and leveled.
- 10. Use a Pre-emergent herbicide for weed control and Irrigate after each application.
- 11. Use planting ratio of 35 bushels per 1,000 sq. ft.
- 12. After planting, apply a light topdressing to keep sprigs from moving to adjacent plots.
- 13. Irrigation should be applied at least once a day, until sprigs are actively growing, and subsequently as needed to encourage rapid establishment.
- 14. Fairway types will be mowed at 1/2" twice per week.
- 15. Putting green types will be mowed daily at 0.125".
- 16. Apply post-emergent herbicides as necessary.
- 17. Fertilize following IFAS guidelines.
- 18. Do not apply fungicides.

## Site Layout, Installation and Management of Trials with Less Advanced Lines:

1. Year 1: Nursery blocks of each line will be established in AFRU, Alachua, FL

2. Year 2 - 4: Establishment and evaluation of a replicated trial at PSREU, Citra, FL

A. Plots will be 5' x 5' with two or three replications.

B. Site preparation, planting/establishment, mowing, irrigation and management will occur as described above for the advanced trials.

## **Evaluation Criteria for Advanced and Less Advanced Trials:**

**Quality**: Collect monthly overall appearance of the turf, incorporating density, texture, uniformity, color, diseases and insect damage. 1-9, where 9 = highest quality.

**Color**: Genetic color, note yellowing or browning due to mower injury, drought stress, etc. and taken when the grass is not under stress. 1-9, where 9 = darkest green color.

*Seed heads*: Record seed heads present. 1-9, where 9 = lowest number of seed heads.

Establishment: Percent of plot established.

**Diseases:** Submit diseased tissue for ID and rate the presence of diseases. 1-9 (1= severely affected; 9= no disease).

*Insects:* Grade insect presence or symptom using the following scale: 1-9 (1= severely affected; 9= no insect damage).

*Late fall color retention:* Grade the color during the fall using the following scale: 1-9 (1= brown/dormant; 9= dark green/non-dormant).

*Early spring green–up:* Grade the color during the spring using the following scale: 1-9 (1= brown/dormant; 9= dark green/non-dormant).

**Drought resistance:** Stop all supplemental irrigation at a specified date and separately rate for turf quality and leaf firing. (1= completely fired; 9= no leaf firing).

**Ball speed:** Record ball roll speed using a stimpmeter.
